4. Cargo free time on the terminal or in the shed:			
	a) Import , thirty (30) calendar days cargo free time commencing after complete vessel discharge.		
	b) Export, thirty (30) calendar days cargo free time commencing upon any portion of cargo arrival on the terminal.		
	c) Empty containers (7) calendar days free time commencing after discharge.		
5. Storage rate:			
A. A storage rate of \$0.35 per tonne W/M will be assessed against the cargo calculated on the average for seven (7) calendar day periods or fraction for remaining on the terminal or in the shed after the expiration of cargo free time.			
B. A storage rate of \$3.10 per empty 20 ft. container and \$4.65 per 40ft container or larger will be assessed per week or part thereof after the expiration of empty container free time.			
6. Truck scale rate:			
Use of the terminal scale will be charged at a rate of \$50.00 per truck-load with a maximum charge of \$2,500.00 per vessel discharge or load.			
7. Security charge:			
Upon vessel arrival and through departure, the vessel operator will be charged \$25.00 per hour, per person or part thereof. Any other request for security will be charged \$25.00 per hour, per person.			
8. Berth reservation application:			
All applications for vessel berth reservation shall be made in the form specified by POSH management as incorporated into the tariff.
