All applications for vessel berthing reservations shall be made in the form specified by POSH Agency as incorporated into the tariff.

<b>11. Fenders per 24 hr period or part thereof (max 4 fenders, includes gangway rental) .....</b>		\$3,450.00
<b>12. Additional fender(s) per 24 hr period or part thereof, per fender.....</b>		\$775.00
